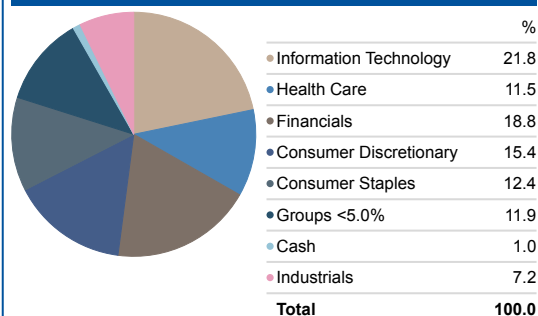

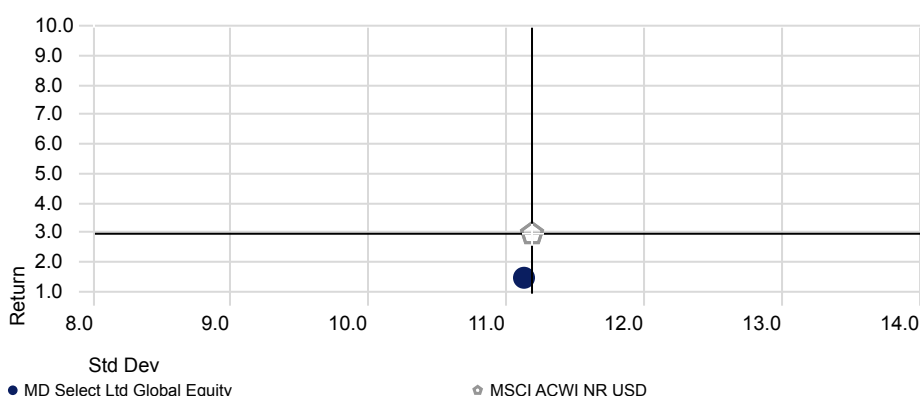

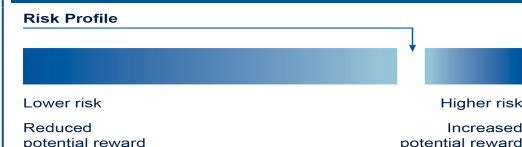
**Mervin Naidoo**
